SAFE SCHOOLS AFRICA - AMEND'S SAFE SCHOOLS AFRICA PROGRAM AIMS TO IMPROVE ROAD SAFETY AROUND SCHOOLS IN AFRICA BY PROVIDING LIFE-SAVING INFRASTRUCTURE SUCH AS FOOTPATHS, PEDESTRIAN CROSSINGS, AND TRAFFIC CALMING MEASURES. THE PROGRAM HAS BEEN IMPLEMENTED IN 10 AFRICAN COUNTRIES, IMPACTING OVER 200,000 CHILDREN. THE INITIATIVE COLLABORATES WITH GOVERNMENTS AND DEVELOPMENT BANKS TO INCORPORATE SAFETY MEASURES INTO ROAD PROJECTS, ENSURING SAFER SCHOOL JOURNEYS FOR VULNERABLE CHILD PEDESTRIANS. THE PROGRAM TARGETS PRIMARY SCHOOL STUDENTS, DELIVERING ROAD SAFETY EDUCATION, ORGANIZING DRAWING COMPETITIONS, AND FORMING "BE ROAD SAFE AFRICA" CLUBS. THESE ACTIVITIES AIM TO REDUCE ROAD TRAFFIC INJURIES AMONG CHILDREN AND PROMOTE ROAD SAFETY AWARENESS. HIGHLIGHTS INCLUDE THE INTRODUCTION OF "KIDS' COURT," WHERE CHILDREN ENGAGE WITH DRIVERS TO PROMOTE SAFER DRIVING HABITS. THE PROGRAM ALSO ENGAGES LOCAL GOVERNMENTS, SCHOOLS, AND COMMUNITIES TO FOSTER A BROADER CULTURE OF ROAD SAFETY ACROSS THESE COUNTRIES.
